This includes, but not limited to, accurate and timely calculation of current revenue, posting of monthly revenue journal entries, revenue variance analysis (month-on-month, quarter-on-quarter, etc.), deferred and unbilled balance sheet reconciliations, various revenue-related metrics, as well as a full range of ad hoc projects for continued efficiency improvements. Responsibilities:

- Actively participate in month end closing activities including:
- Review of contracts and Sales Agreements
- Communicate and coordinate with upstream operational group (Sales, Billing, etc) to research revenue recognition issues
- Calculate contracted fixed and variable to be invoiced
- Preparation of revenue amortization & recognition journal entries as well as other manual adjusting/reclass entries
- Review of monthly accruals to ensure accuracy and compliance
- Credit memo review and reporting
- Revenue analytics (MoM, QoQ, YoY, actual vs run rate, actual vs. budget, etc)
- Revenue-related balance sheet reconciliations (deferred and unbilled)
- Ad Hoc projects as required
